

## **2014 CEAP-NBEC SUMMIT**

28-29 January 2014 (De La Salle University, Manila)

12-13 February 2014 (Waterfront Hotel, Cebu City)

### ***Background and Rationale***

The 2014 CEAP-NBEC Summit shall focus on two critical areas of concern for basic education schools: Senior High School and RA 10627 or the Anti Bullying Act of 2013.

The implementation of the K to 12 Program of the P-Noy government started in SY 2012-13 with the new curriculum in grades 1 and 7 plus the addition of universal kindergarten before six (6) years of elementary, four (4) years of junior high school and two (2) years of senior high school. The addition of two years, Grades 11 and 12, or Senior High School (SHS) is central to this program. The nationwide roll out of Grade 11 shall be in SY 2016-17.

On the other hand, all basic education schools are expected to be familiar with RA 10627. This landmark legislation was passed on 6 September 2013 and all schools are expected to have enacted school policies and procedures consistent with the said law by SY 2014-15.

Part I of this Summit shall address the twin concerns of schools at this time in anticipation of the implementation of SHS. These are: the SHS Curriculum and the Proposed Universal Tiered Voucher System.

Part II shall be a presentation and discussion of the Anti-Bullying Act of 2013 and its Implementing Rules and Regulations.
