Background/Rationale

Background/Rationale

- The addition of two years, Grades 11 and 12, or Senior High School (SHS) is central to the K to 12 program.
- The nationwide roll out of Grade 11 shall be in SY 2016-17.

Background/Rationale

- All basic education schools are expected to be familiar with RA 10627.
- This landmark legislation was passed on 6 September 2013 and all schools are expected to have enacted school policies and procedures consistent with the said law by SY 2014-15.
