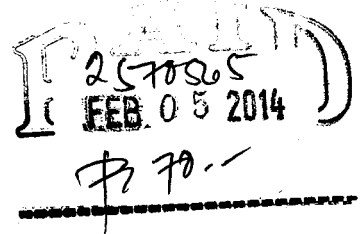



A verified civil case to declare unconstitutional BIR Revenue Memorandum No. 20-2013 with prayer for issuance of Temporary Restraining Order and Writ of Preliminary Injunction having been filed before this Court, praying that a preliminary injunction be issued against Kim Jacinto Henares, Commissioner of Bureau of Internal Revenue, enjoining her, the agents and representatives of the Bureau of Internal Revenue from implementing Revenue Memorandum No. 20-2013.
